

Christ Lutheran Church and School COVID-19 Safety Plan for 2021/2022

Christ Lutheran Church and School is committed to providing a safe learning and working environment for all stakeholders in our community. In order to achieve this goal we will follow a multi-layered approach in addressing current health and safety concerns.

MULTI-LAYERED SAFETY APPROACH INCLUDES

- Pre Screening at home
- Masks/face coverings (more details below)
- Regular handwashing
- Air purifiers in every classroom
- Sanitizing student desks and common touch points daily
- Students and staff staying home when sick
- Case reporting to county
- Modified quarantine of students when coming in close contact with someone infected
- Isolated quarantine of students and staff when infected

PRESCREENING

Employees, students, and guests are asked to self-assess at home through temperature screening before entering campus.

Any individual who is not feeling well, has COVID or flu-like symptoms, and/or has a temperature at or above 100.4°F needs to stay home.

MASKS

The California Department of Public Health strongly recommends individuals wear masks indoors regardless of vaccination status.

Students, teachers, parents, volunteers and guests may choose to wear a mask while indoors, but it will not be required.

RESPONDING TO POSITIVE CASES & CLOSE CONTACTS

The Orange County Health Care Agency continues to update its orders and strong recommendations for county residents and visitors. The most recent County of Orange Health Officer's Order and Strong Recommendations can be found <u>HERE</u>.

CLS is legally obligated to follow the current orders and school staff will instruct families using county orders on whether their student may or may not attend school if they become positive with COVID-19 or have become a close contact with someone who is positive with COVID-19.

INSTRUCTIONAL MATERIALS FOR STUDENTS IN QUARANTINE

For students who undergo quarantine, instructional materials will be provided from the classroom teacher to support learning at home. CLS will not be offering video conferencing for students undergoing quarantine. We encourage families to be in communication with teachers regarding assignments.

COMMUNITY NOTIFICATION OF POSITIVE COVID-19 CASES

Families are notified in our weekly communication regarding the total active number of positive cases within the day school, or preschool population.

- 0 3 positive cases on campus are indicated as WHITE status.
- 4 6 positive cases on campus are indicated as YELLOW status.
- 7 14 positive cases on campus are indicated as ORANGE status.
- 15 + positive cases on campus are indicated as RED status.

If a student has a positive test result for COVID-19, CLS will maintain confidentiality and protect student privacy, following all FERPA protocols. Close contacts of a student with a positive test result for COVID-19 will be notified.

REQUIRED VACCINATIONS

CLS only requires the vaccinations that are required for students enrolled in a school as a condition of the state Education Code, as outlined by the California Department of Education.
